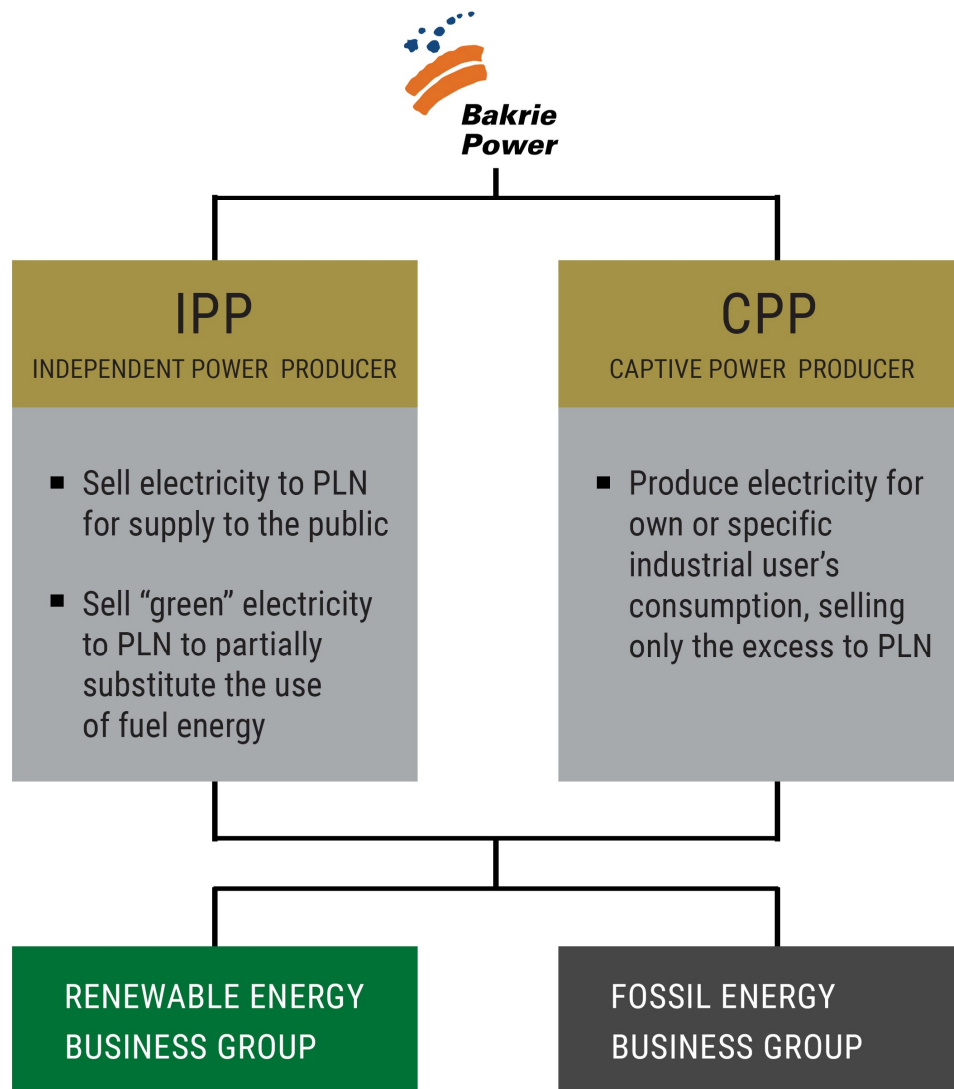
A. Amri Aswono Putro, Director

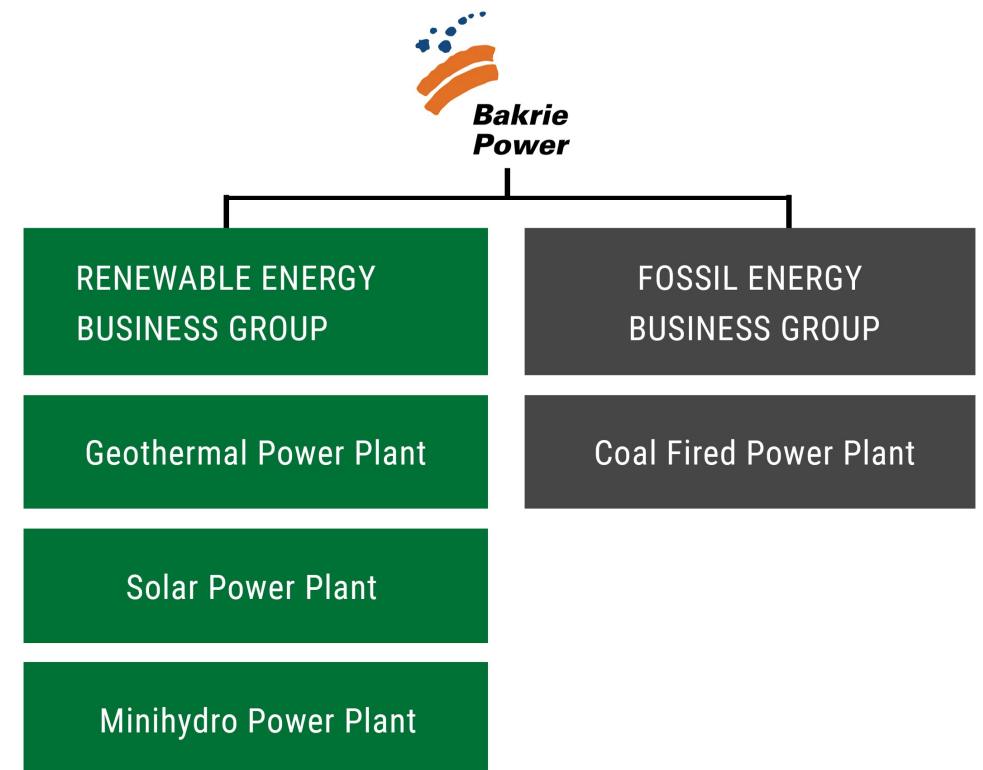

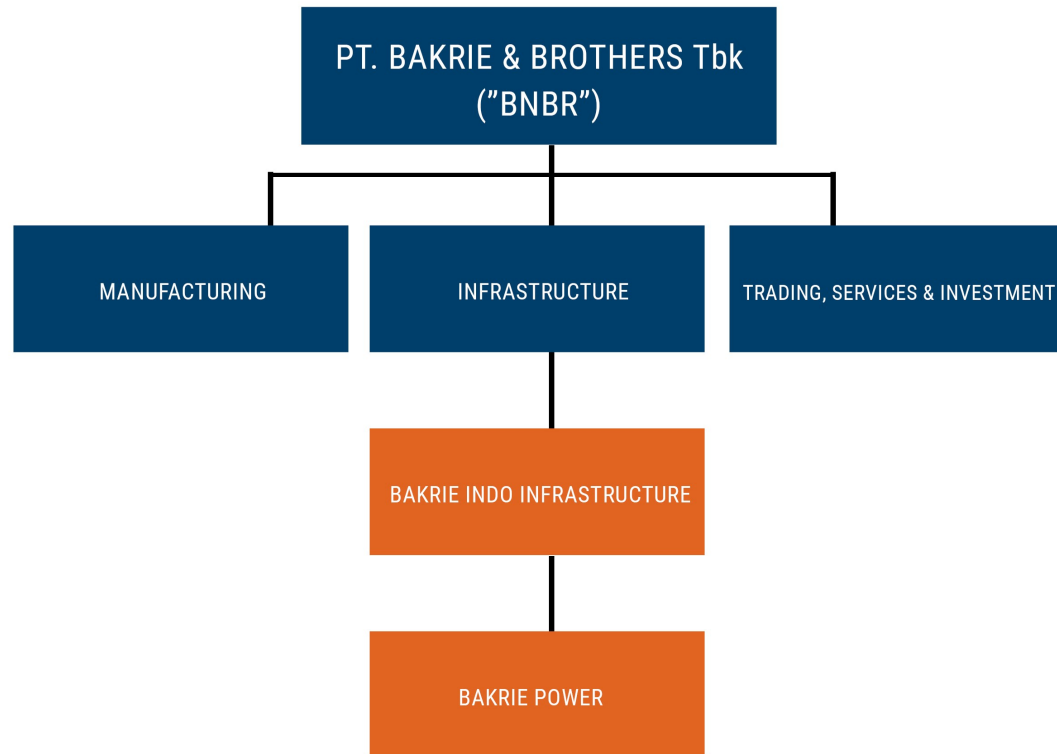

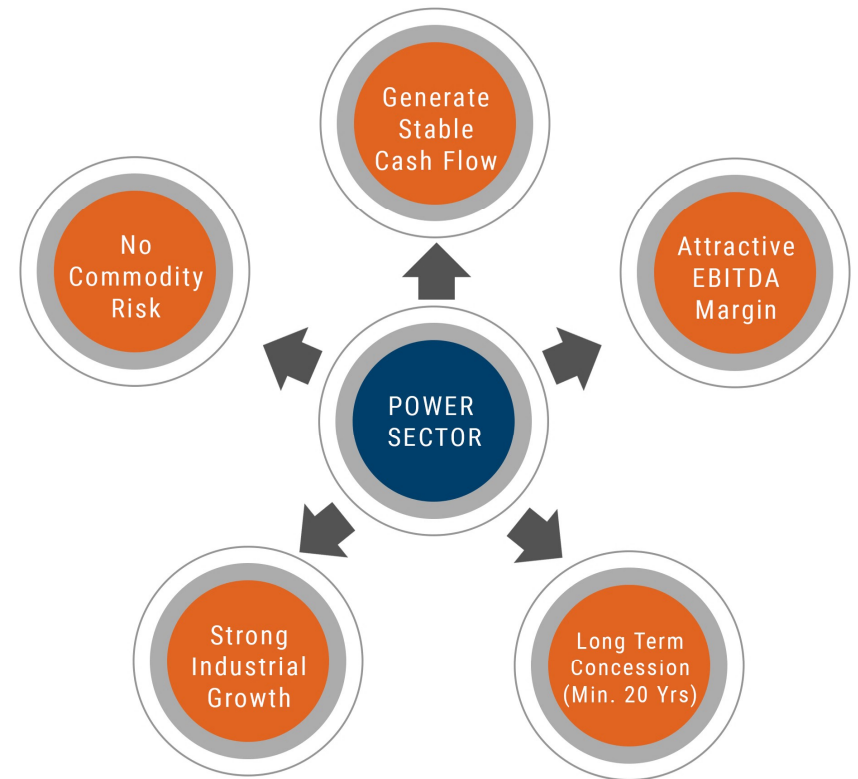
OUR BUSINESS MODEL
